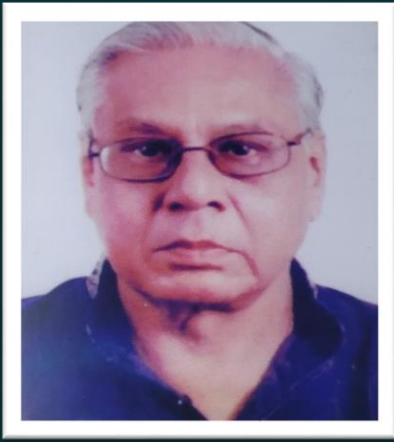
Bimal Chandra Sinha

Late Bimal Chandra Sinha of Kandi Raj family was born on 1st December, 1918 to an illustrious Zamindar Family of West Bengal. He had a brilliant academic career.

He stood first in B.A. & M.A. in Economics from Calcutta University. He was elected several times in West Bengal Legislative Assembly. He joined as Cabinet Minister on 7th July, 1947 in Dr. Prafulla Ghosh's ministry in department of Health and Local Self- government and after independence he resigned on 2nd September, 1947.

He was inducted again in Dr. Bidhan Chandra Roy's cabinet on 23rd January, 1948 as work, buildings, and communication Minister. He was elected again to Bidhan Sabha in 1957 from Kandi of District Murshidabad and was minister in land reforms and land revenue department in Dr. B. C. Roy's Cabinet and continued till his death on 17th April, 1961. though he was a Zamindar, but also, he was the main architect in abolishing Zamindari System in West Bengal in 1953. When India become independent on 15th August 1947 then Murshidabad district was annexed with East Pakistan (now Bangladesh) then Sri B. C. Sinha's untiring effort compelled the union to add Murshidabad into the territory of India. The main communication roadways were first constructed with the aid and advice of Sri Bimal Chandra Sinha. He had several publications to his credit. Some of the books authored by him includes – *বাংলার চাষী, বিশ্বপার্থক্য বাঙালী, বঙ্কিম কাণিকা, তৎকালিক, বঙ্কিম প্রতিভা, ইতিহাসের শিক্ষা ও ভারতের রাজনৈতিক কর্মসূচী, খাতার পাতা, দায়ভাগীর প্রবন্ধাবলী, সমাজ ও সাহিত্য, দেশের কথা, শিক্ষা সমস্যার কয়েকটি দিক, দোসরা অক্টোবর & এলো ডোরা ভো।*





Atish Chandra Sinha

Founder President of

Late Sri. Atish Chandra Sinha, the worthy son of late Bimal Chandra Sinha, son of Kandi Raj family and a minister in the Sidhartha Sankar Roy's Cabinet, was born in the Kandi Raj family on 27th July, 1940. A brilliant Scholar of Presidency College, Kolkata. He specialized in Geophysics from the Imperial College in London. He started his schooling at Scottish Church Collegiate School and then after he obtained his B.Sc. Degree in Geophysics with 1st class honours from Presidency College, Kolkata, and later obtained D.I.C. (Diploma in Imperial College) degree from IMPERIAL COLLEGE OF SCIENCE AND TECHNOLOGY, LONDON.

There after he took job as executive in Digboi (Assam) Oil field. After that he was married with late Smt. Archana Sinha, daughter of late Radha Damodar Mitra. For the fulfillment of urge from the common people of Kandi, he joined politics for the purpose of development of Kandi subdivision and was elected as member of 6th West Bengal Legislative Assembly from Kandi constituency in 1971. In 1971, he served as Minister of State for Department of Public Undertakings and Department of Cottage and Small-scale Industries. After that he was also elected as the member in 7th (1972), 8th (1977), 9th (1982), 11th (1991), 12th (1996), 13th (2001) West Bengal Legislative Assembly. During his tenure he created job opportunities for the unemployed and offered irrigation facilities to the vested land holders of Kandi locality. He took initiative to establish F.M. radio station at Berhampore and establish fire brigade station near Kandi. In Kandi locality so many School, Colleges, and Health centres for the kind patronage of late Sri Atish Chandra Sinha. Meanwhile he was also elected as Member of Parliament in December 1984 defeating the veteran R.S.P Leader Sri. Tridiv Chowdhury. Late Sri. Atish Sinha hold many portfolios of political importance, those are member of the select committee in West Bengal Land reforms (2nd Amendment) Bill in 1980, Member of the Select Committee in West Bengal Panchayat (Amendment) Bill in 1992, Leader of the Opposition of West Bengal Legislative Assembly in 1996 and Chairman of Standing Committee in Urban Development and Municipal Affairs in 2001. He was also executive member of Mohunbagan Athletic Club and Vice President of prestigious South Calcutta Club. Sri. Atish Chandra Sinha accomplished this herculean task of establishing a law college with sheer desire to impart legal education and create social engineers as he could not continue his legal education. Hence, he wanted to materialize it by establishing a Law College in the loving memory of his father Late Bimal Chandra Sinha for the law aspirants in the year 2002. He left us on March 4, 2010 to embrace heavenly light. The people of Kandi and the BCCL family lost a great human being, great education lover and loving leader. He will be always in the memories of people of Kandi.

Prof. (Dr.) Bikash Chandra Sinha

Bikash Chandra Sinha was an Indian physicist who was active in the fields of nuclear physics and high energy physics. Sinha was the director of the Saha Institute of Nuclear Physics and Variable Energy Cyclotron Centre and the chairman of the Board of Governors of the National Institute of Technology, Durgapur in June, 2005. He was also a member of scientific advisory board to the Prime Minister of India.

He joined Bhabha Atomic Research Centre, Mumbai in 1976 after returning from England and was Director of Variable Energy Cyclotron Centre, where he was the Homi Bhabha Chair Professor. He retired from service as the director of Variable Energy Cyclotron Centre and the Saha Institute of Nuclear Physics in June 2009.

He specialized in nuclear physics, high energy physics, quark–gluon plasma and early universe cosmology. He is credited with helping India achieve recognition in the global science community. He contributed to making India join the search for the Higgs boson at CERN, helping the search that lasted from 2008 to 2012, which eventually culminated with the discovery of the Higgs boson. At CERN he also worked in creating and researching quark–gluon plasma alongside searching for the Higgs Boson. Sinha additionally led his team to do experiments at the Relativistic Heavy Ion Collider at the Brookhaven National Laboratory in the US and the Facility for Antiproton and Ion Research in Germany. Sinha was the chairman of board of governors, National Institute of Technology, Durgapur (NIT Durgapur). He was nominated as a member of the Scientific Advisory Council to the Prime Minister from 27 January 2005. He has been re-elected for the second time as a member of the Scientific Advisory Council to the Prime Minister from December 2009. Sinha died on 11 August 2023, at the age of 78, in Kolkata.

He was the recipient of S.N. Bose Birth Centenary Award of the Indian Science Congress Association in 1994. He was awarded D.A.E. – Dr. Raja Ramanna Prize 2001 and delivered the Pandya Endowment lecture Award, IPA, 2001 and Rais Ahmed Memorial Lecture Award, Aligarh, 2001. Sinha was awarded the R.D. Birla Award for Excellence in Physics in 2002.

Sinha was conferred the Padma Bhushan Award in 2010 for his significant contribution in science and technology. He also received the Padma Shri in 2001. He was made a fellow of the Indian National Science Academy due to his research in Physics (1989). He was also a Fellow of National Academy of Sciences, Allahabad (1993) and the Indian Academy of Sciences, Bangalore (2004). He was also awarded an Honorary Doctorate from Netaji Subhas Open University in 2013, and National Institute of Technology Agartala in 2013. He left us on August 11, 2023 to embrace heavenly light. The people of Kandi and the BCCL family lost a great human being, great Scientist. He will be always in the hearts of people of India.

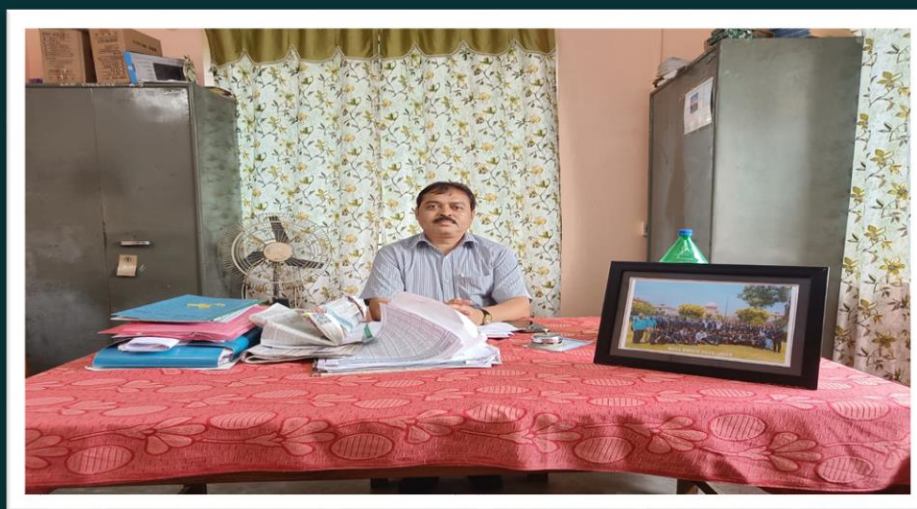

The College was found on the philosophy that knowledge is virtue & enlightenment and in turn enlightenment leads best to inculcate this value among students.

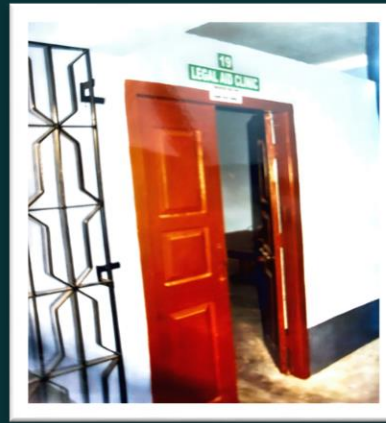
In a nutshell it aims at internalization of the knowledge of law & legal process to develop a sense of social responsibility among students and scholar to serve society and contributed socio-economic development.

LIBRARY

Library being the heart of an academic institution, BCCL may take pride of its well-equipped, well managed and well-furnished library run by professional librarian and two supporting staffs. The facilities at library include reading section with ample space, borrowing rights for stipulated time period. Library has a good collection of text books, reference books, back volume of journals & reports from 1950 to up-to-date. It also subscribes to various reporters, five Periodicals, ten Magazines and five Newspapers. We propose to introduce the system of self-access to book shelves and other study materials to facilitate reference to various source materials for intensive study and research work. This is to inculcate research ability among students as it is one of the salient features of legal education. Our competent library staffs are readily available for assistance to the students and at times even faculty members are also available for required guidance.

Library Hours

Library remains open from 11:00 a.m. to 5:00 p.m. on working day *i.e.*, Monday to Friday.



Library Card

Students need to furnish their fee receipt and the College Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non-transferable.

All bonafide student of the college are entitled to avail reading room and borrowing of books and other study materials for home facilities. Library fine will be imposed in case of non-return of books or any misconduct in the library room.

- Three books will be issued to a student at a time.
- Books borrowed must be returned within a fortnight. A fine of 50 ₹ per month will be charged after the due date of return.
- If the book is lost by any student, he will have to pay 50 ₹ plus the present actual price of the book and also in the case of scribble in underline or cripple a book.

ADMISSION IN 5 YEARS B.A.LL.B. (HONS.) DEGREE PROGRAMME

❑ *Eligibility*

- Any candidate who is applying for B.A.LL.B. (Honors) must fulfill following criteria
 - Qualification: Have Passed the Higher Secondary (10+2) or an equivalent examination securing in aggregate not less than 45% (General Category), 42% OBC or 40% (SC/ST Category) of the total marks.
 - Age: A candidate must not have more than 20 years of age as on 1st day of July of the respective year of admission. In case of candidates belonging to SC/ST/OBC category a relaxation of 2 years in age shall be admissible.

❑ *Number of Seats and Reservation*

- The intake of seats available for 5 Year B.A.LL.B. (Honors) degree program shall ordinary be 60 (sixty) in each section. Out of these total available seats 22% for SC, 6% seats are for ST, 10% OBC(A), 7% OBC(B) and 3% for Physically Challenged categories respectively, subject to their fulfilling BCI eligibility criteria.

❑ *Prospectus and Application Forms*

- Prospectus and Application Forms can be obtained by hand on payment of Rs. 400/- (Rupees Four Hundred only) in cash from College Office BCCL Admission Cell.

❑ *Norms for Admission & related information: -*

Attested Photostat copies of the following documents should be enclosed with the Application Form:

1. Mark sheet of the Higher Secondary (10+2) or equivalent examination. Candidates who have appeared at the above examination and who are awaiting their results by June/July can submit their Application Form.
2. Proof of Age - Birth Certificate or Admit Card/ School Certificate mentioning the date of Birth.
3. Caste Certificate - In case of candidates belonging to any above-mentioned category.
4. Recent Passport size colour photographs - One pasted on the Application Form and two extra copies along with the Application Form.
5. Collection and submission of duty filled in admission form is to be made in due time.
6. Admission is direct for all the general category students securing 45% marks, 42% Marks for the OBC Students & for the student belonging the scheduled caste & schedule tribe category securing 40% marks in the Higher Secondary or equivalent examination in the aggregate. Admission starts after the publication of result by the West Bengal Board of Higher Secondary Education or equivalent examination, usually in the month of June, the admission forms along with prospectus & fees book of the college can be obtained from the office of the college against a cash payment 400/- only. The last date for issue and submission of admission forms shall be notified separately on the college notice board. The full fees & dues once paid by the students shall not be refundable under any circumstances. Merit list of selected candidates admitted to 1st year will be notified in college notice board. Migrating students from other boards are provisionally admitted subject to the production of required documents as notified in the notice board of the college. Admission to 1st semester of the 5th year B.A.LL.B. (Honors) course commences after publication of result of the Higher Secondary Examination, West Bengal and closes on such date as specification by the Kalyani University each year. Year to year class admission is compulsory of stipulated dates. The annual course fees may be revised after admission during 5 years course tenure.

Benefits of Teamwork

Problems solving: A single brain cannot bounce different ideas of each other. Each team members have a responsibility to contribute equally and offer their unique perspective on a problem to arrive at the best possible solution. Teamwork can lead to better decision, products, or services. The quality of team work may be measured by analyzing the following six components of collaboration among team members: Communication, coordination, balance of member contributions, mutual support, effort, and cohesion. In one study, teamwork quality as measured in this manner correlated with team performance in the areas of effectiveness (*i.e.*, producing high quality work) and efficiency (*i.e.*, meeting schedules and budgets). A 2008 meta-analysis also found a relationship between teamwork and team effectiveness.

Accomplish tasks faster: A single person taking on multiple tasks will not be able to perform at a same pace as a team can. When people work together, they can complete tasks faster by diving the work to people of different abilities and knowledge.

Healthy competition: A healthy competition in groups can be used to motivate individuals and help the team excel

Developing Relationships: A team that continues to work together will eventually develop an increased level of bonding. This can help people avoid unnecessary conflicts since they have become well acquainted with each other through team work. Team members' rating of their satisfaction with a team is correlated with the level of teamwork processes present.

Everyone has unique qualities: Every team member can offer their unique knowledge and ability to help improve other team members. Through teamwork the sharing of these qualities will allow team members to be more productive in the future.



Rules Mandatory for the Students

- ❑ Attendance
 - Minimum 75% attendance in class lectures is required to enable students to appear at University Examination as collegiate candidate.
 - Every student admitted to the College is required to attend lecture, tutorial, presentations and practical as per the college time table. No student will be permitted to appear in the University examinations unless he/she has attended at least two thirds of the lectures/tutorials/presentations held in all subjects taken together in each semester.
 - Attendance will be taken from day one of the new session. Students are expected to check the status of their attendance record which will be displayed on the students' notice board/College website from time to time.
 - If a student is unable to attend classes because of medical reason, he/she must submit a medical certificate as well as fitness certificate to the College Office not later than a week of rejoining College after illness. Medical certificates submitted late will not be accepted by the College.
- Website & Notice Boards
 - Students should make it a habit to read the notice board/website regularly to check notices for schedule of classes, examinations, holidays, activities, and other information of relevance. Ignorance of any notice will not be accepted as plea or an excuse for any delay in any matter.
- ❑ Identity Card
 - After admission to College, every student will be issued an Identity Card, which he/she should always carry and present it as and when asked for. Failure to do will render a student liable to disciplinary action. The card must be returned when a student leaves the college Loss of Identity Card should be reported to the office immediately. Duplicate Identity Card will be issued on payment of Rs. 70/-
- ❑ Visitors
 - Students are not permitted to receive or entertain visitors in the College. In case of extreme urgency, they must seek prior permission from the Principal or in his absence from the Vice Principal / TIC.
 - Internal Assessment
 - Internal Assessment is governed by the ordinance of the University of Kalyani, as amended, and notified by the University of Kalyani from time to time.
- ❑ Notification
 - In case of loss or damage of Fees Card/ duplicate card may be issued on payment of a fine of Rs.50/- subject to verification.
 - Authority of the college may impose fine or adopt other measures to maintain strict academic discipline of the college. The students are required to maintain proper uniform code while in the premises of the college.

❑ *Anti Ragging Committee*

In reference with Supreme Court ruling and UGC Regulation 2009, curbing the menace of Ragging, we completely ban any form of Ragging. ❑ *Free Legal Aid Cell*

Course Fees

- ❑ The fees for the B.A.LL. B (Honors) degree program for each academic year shall be 30,000 ₹ (Rupees Thirty Thousand) only *i.e.*, 15,000 ₹ per semester exclusive of examination and other fee payable to university.
- ❑ However, an additional 10% of the total course fees for 5 years shall be payable to the university by the student at the time of admission in one installment as the university registration fee with effect from academic session 2010-11.
- ❑ The fee shall be due at the beginning of each academic session. However, the students with the permission of the principal/Teacher-in-charge, BCCL on furnishing reasonable ground may pay the fees in installments. The 1ST Installment is payable at the beginning of each semester. If the fee is not paid within due time a fine may be imposed on the student of 1,000 ₹.

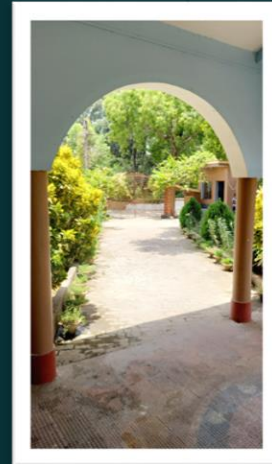
